Before the Tournament:

1. Check out the CFL website for specific information regarding the tournament. The link is:
<http://www.omahancfl.com/>

2. Entry fees are \$35 per person (Duo/PFD/Policy = \$70). You need to get your entry fee checks to Cathy ASAP. We pay the entire diocese entry and expect you to pay us what you owe – we don't have enough money to cover you.

3. Judges. I need to have your judge names immediately. I must register us for the national tournament this upcoming week and a part of that registration is having judge names to plug in. Please get those to me. You need 1 judge for every TWO IE entered. 2 judges for every POLICY debate entered. 1 judge per LD/PFD team.

A. I need someone who has a student congress kid entered to have a judge with student congress judging experience – we only need one for our diocese. Any volunteers?

4. Rules – make sure you look at the “official by-laws” on the CFL website. I asked about the problem where the ballots directions don't match the by-laws. I was told that the by-laws are the guiding factor. So, Max your Duo issue regarding being on the ground – the ballot doesn't say you can't be on the floor, but the by-laws do. I guess get on the floor at your own risk.

5. I need you to send me your contact info. Email me the name of the hotel you are staying in, that hotel's phone number, and your cell phone. I will send this list out to everyone so just in case you need to contact someone else in our diocese you can.

1. Seaman High School will be staying at the Holiday Inn Convention Center @ 3321 S. 72nd Street. The phone number is:

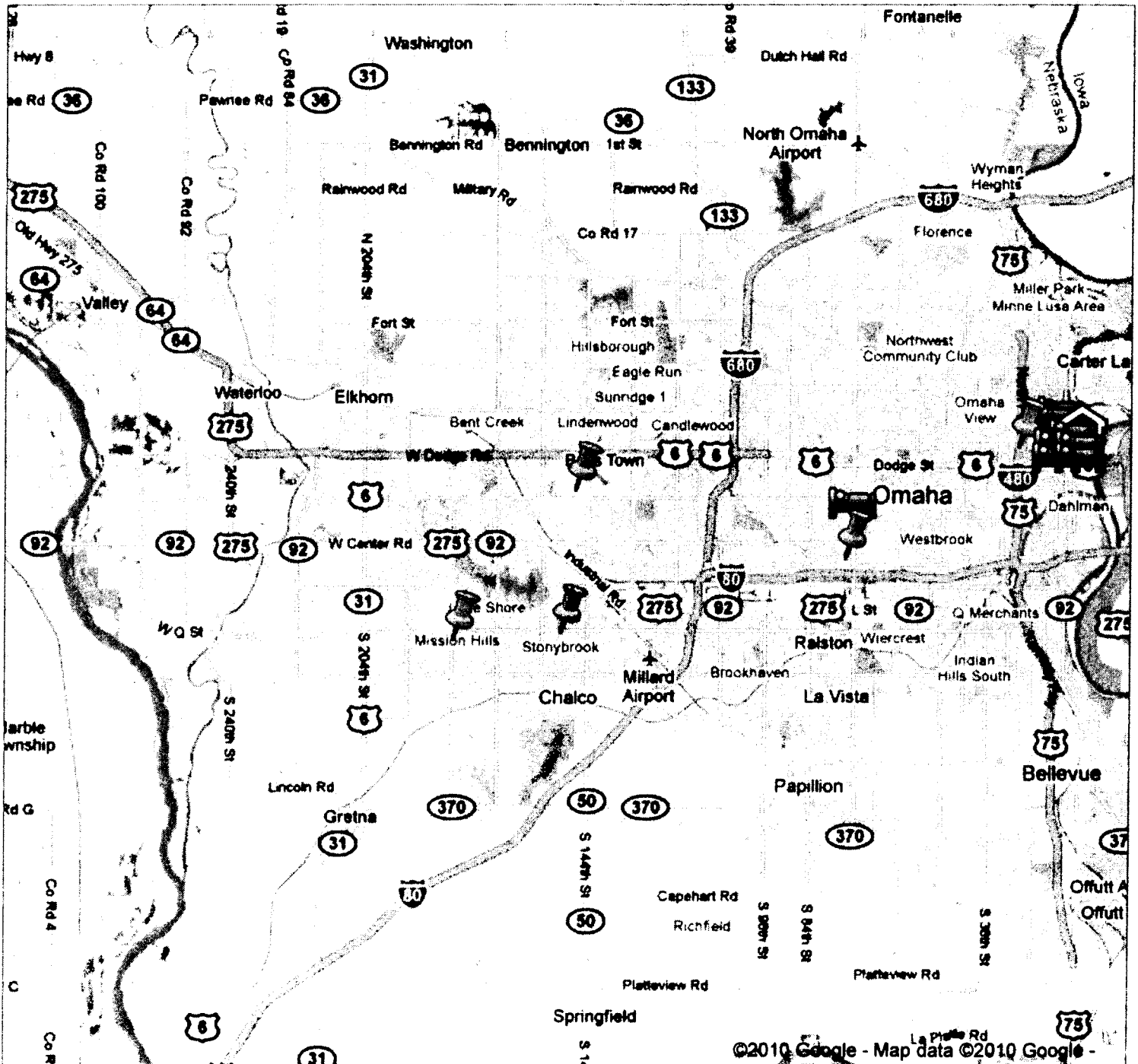
